

# ECSA CONFERENCE // 2020

## General terms and conditions for attendance at the Third International ECSA Conference 2020 (ECSA 2020) from September 6<sup>th</sup> to September 8<sup>th</sup> 2020 in Trieste, Italy

**Scope:** The following general terms and conditions govern the contractual relationship between the participant at the ECSA 2020 and Sissa Medialab. Terms and conditions of attendance that are different from the below noted conditions are not valid. Registration/Confirmation of registration: Registration is done online. The confirmation of registration is sent out via email after payment. The confirmation is legally binding. You will receive your ticket and invoice only after payment. Payments have to be settled within maximum two weeks from registration and all prices are quoted in EURO (EUR).

**Conference package:** Each participant must register and thus obtain a ticket. The ticket is valid for the entire ECSA 2020, with the personalized badge giving access to the conference. The conference package includes admission, conference documentation, lunches (September 7<sup>th</sup>, September 8<sup>th</sup> 2020), refreshments/coffee breaks (September 7<sup>th</sup>, September 8<sup>th</sup> 2020) and the social dinner (September 7<sup>th</sup> 2020). There is no reimbursement for any part of the package that is not used. Sissa Medialab reserves the right to replace announced speakers with others if needed and to make necessary changes to the programme of events. If the conference cannot take place due to force majeure or good cause (for example, due to illness of many speakers or due to insufficient number of participants), the participants will be informed immediately and the registration fees reimbursed. No claim can be made for reimbursement of travel and lodging expenses. No reimbursement will be paid for the cost of the loss of work.

**Payment method, due date and late payment:** Payment can be made via bank transfer or Paypal; payment in cash or by cheque is not possible. If the payment is 14 days late a reminder is sent; if payment is still not made the registration will be cancelled. Cancellation and transfer: The registration may be cancelled up to 30 days before the start of the conference. The cancellation is made by writing to the organizers at [ecsa2020@medialab.sissa.it](mailto:ecsa2020@medialab.sissa.it). Participants are charged 10% of the ticket price for cancellation + processing fees.

**Personal Data:** Personal data are protected. Sissa Medialab will handle the data provided by participants confidentially and use the data only in compliance with the legal provisions on data protection. All personal data provided during the registration process will be stored and used by Sissa Medialab. The list of participants, if consent is given, will be available to all participants. The personal data of participants will not be shared with third parties. The conference website is using Google Analytics, that uses cookies to track the number and location of visitors of the conference website. Such analysis may be used to gain insights about how to improve the functionality and experience of the website.

**Photography/Recording:** We do not ban participants, exhibitors, partners from taking photographs of conference activities and participants. However, we do give you the possibility upon registration to specify whether you agree to be photographed/recorded or not during the conference and, based on your decision, you will be provided with a distinctive lanyard.

**Applicable law, place of jurisdiction and place of fulfilment:** Italian law shall apply; the place of jurisdiction is Trieste.
